According to the research, the cause of crime, the development of illegal behavior and peculiarities in the individual, and the occurrence of various offenses, the factors that harm the law and prevent its implementation, are influenced by the family. In addition, an unhealthy social psychological environment in the home plays a necessary role in the occurrence of any offense in some cases, sexual relations are regulated by the rules of etiquette[1].

As noted by F.M. Otahojayev, the scope of family law is widespread in society, it is the regulation of family law relations between divorce, termination of marriage, adoption, foster care, patronage, foreign citizens and stateless persons. It must be said that the root of any offense and unpleasant vices is built in the family. The family plays an important role in the preparation of the individual for social life, in the development of human qualities such as spiritual and ethical upbringing, and behavior.

Today 40% of crimes against the life and health of the city, one in four murders, one in five intentional bodily harm, and one in eight homicides and slander occur in the family sphere. The President Republic of Uzbekistan Sh. Mirziyoyev said: "I am disturbed by the unhealthy relationships in the families, the quarrels between the mothers-in-law, the husbands and wives, and the suicides among our wives and daughters[2]".

Crimes in the family in this family, crimes are connected by one members of the family against another member. In this case, the relationship between the spouses does not matter whether it is legally or illegally.

Within the family, crimes are often committed by a man (woman) against a woman (man). All over the world, many families use violence against children as a form of crime. Violence used to exercise power through the performance of family responsibilities (for example, the exercise of parental rights has legal legitimacy. At the same time, violence can be seen in verbal expression, in spiritual influences, and in the performance of one's duties (for example, apart from land or imaginary financial aid). It was not always clear that the adults were violating the criminal code by using violence against children in the family and by standards of behavior that were molded during the captivity. Many of these crimes, especially if they do not cause great harm to human health, resulting in death or injury, remain unknown to those around them and do not lead to appropriate action. Crimes of varying severity were forcibly prosecuted. Among them are crimes against life and health (especially murder and intentional infliction of grievous bodily harm) and crimes against sexual freedom. In Russia, for example, about two million children die every year as a result of domestic violence. More than 10,000 dreams have died from everyday life conflicts. Most of crimes committed in the city were committed under the influence of alcohol or drugs.

The crime committed in the case of affect is directly related to the crime. In 90 % of cases, it was a psych traumatic event that lasted a long time in the village, and many years of violence and crimes were committed under the influence of accumulated lung. In most countries, women are more likely than men to be victims of crime. One of the crime of domestic violence is the murder of a husband (wife), a wife (husband) is divided into 3 types:

- 1) To killing of a man (woman) for greed

This type of homicide accounts for only 5 % of all homicide cases. Greed may be an intention to avoid paying alimony for murder, to acquire housing, to expedite inheritance

- 2) Approximately 50% of murders by man (woman) or vice versa in order to get rid of various jobs

Such as activity may include the need to constantly look after the sick or the elderly, or the need to look after the child in a different way.

- 3) More than 50% of a man (woman) on the basis of jealousy

Much of the violence against women is perpetrated by domestic violence. Due to the sensitivity of interpersonal relationships and the secrecy of the relationships, a great deal of scientific experience is required from the work of internal affairs departments in the field of prevention.

In order to implement preventive measures, the internal affairs bodies include:

- Visit the family where the offense was committed and try to resolve the conflict;
- To study current issues in the family and to study the environment in the family and identify the factors that led to the conflict;
- To learn whether this offense has been committed or not, whether there is a conflict between the members of the group, or whether there is a conflict;
- To investigate whether the offense has been committed in the past or not, and whether there is a prior conflict between family members;
- To identify and resolve the lifestyle of people living in the family, the negative impact on the family, to identify the causes of disagreements and conflicts, to take appropriate measures;
- These conflicts lead to the disappearance of the family, the maintenance of the family and stability, the work of the husband and wife in harmony, in consultation with each other, and the training of the existing exercises in the family;
- Conflicts between husband and wife have an unfavorable effect on the upbringing of children in the family, meaning that they are exposed to a number of exercises in the field of education;
- Determine if there is jealousy or infidelity between the couple in the family;

- To study cases in which the mother or father of a husband or mother interferes in the family life and influences it;
- To identify cases of mistreatment, humiliation, abuse of a woman without understanding her;
- To identify and take action against cases of violence against a woman by a man;
- To study the attitude of the husband and other members of the family to the bride; To study the circumstances of the bride's parents, relatives interfering in the family life;
- To take care of the bride in the family, to take care of her needs, to help her with household chores, to understand her, and to put pressure on the bride from other members of the family;
- To find out if the bride has overworked;
- If the mother-in-law has used violence against the bride, the cause of oppression, the only way to talk to her is to give her a protection order;
- A warning of the possibility of taking preventive measures by internal affairs authorities in the event of recurrence of unfavorable circumstances;
- The problems between the husband and the wife alone, the educational, important conversations about the hour that led to the offense, the call to discipline the, as well as the fact that if such an offense is committed, that appropriate measures will be taken in accordance with the law.

The implementation of these measures will be carried out by various authorities: the Department of Internal Affairs and Social Welfare, the Department of Social Welfare, the Ministry of Housing and Communal Services, the Ministry of Education, the Ministry of Health.

V. Andreeva describes the following disagreements of family as follows: "The existence of disagreements in the family may be due to the transition to a new stage of family development and adaptation to new conditions [3]. Disagreements have always led to unfavorable situations, which have disrupted relations between people and adversely affected the effectiveness of the work. Disagreements in the family are one of the most widespread. According to scholars, 80-85 % of the families are witness to the disagreements that take place in the family. The equality of the family relations, the

appearance and development of the alone not only in the midst of the local vulnerability, but also affects the social and spiritual health of all members of the family. Each of the different types of disagreements at different stages of the formation of the family has its own aspects, stages and dynamics. The prevention of domestic violence is considered to be the sole cause of the conflict, not only of the spouses, but also of other members of the family.

In conclusion, the protection of family, the creation of favorable conditions for the physical development and formation of children and adolescents, is the work of both the country and society as a whole.
